Generally, following the donation of an animal, they are examined to determine what, if any, rehabilitative treatment is required. Following such treatment as **Animal Protection Coalition, Inc.**, in its sole discretion, deems necessary, animals are put up for adoption. If an animal is pregnant at the time of its donation, any resulting off-spring shall be the property of **Animal Protection Coalition, Inc.** Any adoption donation received as a result of such adoption is solely the property of **Animal Protection Coalition, Inc.**

Upon receipt of your donation, **Animal Protection Coalition, Inc.** agrees, subject to the foregoing, to provide for the boarding and health care of the animal. **Animal Protection Coalition, Inc.** further agrees to adhere to all relevant federal and Indiana laws pertaining to animal welfare.

No animal will be accepted for donation by **Animal Protection Coalition, Inc.** without receipt of this fully completed donation form. The registration papers, medical history, and other pertinent history, if any, should accompany it at the time of donation. Donors who import animals from out of state must meet Indiana import requirements.
